

## Terms and conditions for Opening Weekend Ticket Incentives

- 1. The Promoter of this competition is Volleyball England, SportPark, Loughborough University, 3 Oakwood Drive, Loughborough, LE11 3QF
- 2. The closing time and date for the competition is 11:00pm Sunday 15<sup>th</sup> October 2023. Tickets are still available for purchase after this date.
- 3. The prizes available will be selected based on the ranking of each club/university based on their attendance at the Opening Weekend event.
- 4. First place will have first choice of the prizes available, followed by second, third, fourth, and fifth.
- 5. The promoter accepts no responsibility for any costs associated with the prize and not specifically included in the prize.
- 6. The top 5 placed clubs/universities will be notified after the Opening Weekend that they are eligible for prize selections and be asked of their preference for the prize.
- 7. The final rankings will be determined on the club/universities' **attendance to the event, NOT tickets sold**. This is to prevent clubs/universities from purchasing large numbers of tickets without attending.
- 8. All physical prizes must be collected from Volleyball England during a future event, or from their head office in SportPark, Loughborough University, 3 Oakwood Drive, Loughborough, LE11 3QF.
- 9. The assigned ticketholder must attend in order to contribute towards the attendance score for the club/university. Tickets will be scanned upon entry.
- 10. The 50% discount on tickets will be calculated a week after the event and a payment to the club will be made. Clubs are then required to distribute to members accurately.
- 11. Free student cup entry will be provided via discount code, sent out once winners have selected the prize.
- 12. The prize is non-exchangeable, and non-transferable.
- 13. The prize cannot be resold or transferred to another person.
- 14. Volleyball England reserves the right to replace the prize(s) with an alternative prize of equal or higher value if circumstances beyond the promoter's control make it necessary to do so.
- 15. Volleyball England shall use and take care of any personal data you supply to it as described in its Privacy Policy, and in accordance with data protection legislation. By entering the competition, you agree to the collection, retention, usage and distribution of your personal information in order to process and contact you about your entry.

Volleyball England accepts no responsibility for any damage, loss, liabilities, injury or disappointment incurred or suffered by you as a result of entering this competition or accepting the prize, except for any liability which cannot be excluded by law (including personal injury, death and fraud) in which case that liability is limited to the minimum amount allowable by law.
