

ROLE DESCRIPTION – PERFORMANCE BEACH COACH

JOB PURPOSE

Working within the Volleyball England and British Volleyball Federation beach performance programme and talent development pathway to deliver technical expertise to beach volleyball performance athletes within the programme.

This includes both leading and/or collaborating with the athletes' personal/assistant coaches to plan and deliver a training and competition programme focused on developing the performance skills required to maximise and realise the opportunity to qualify for the Los Angeles 2028 Olympic Games.

This will include prioritisation of support for national team athletes as directed by the Volleyball England Beach Performance Director and the British Volleyball Federation (BVF) Performance Manager.

KEY RESPONSIBILITIES

- 1. Develop, plan and deliver a training and competition programme for beach performance athletes: Work within the overall beach performance programme and talent development pathway to develop, plan, communicate, and deliver, in conjunction with personal/assistant coaches, an athlete-centred programme of training and competition through the Los Angeles Olympic cycle and beyond. It is anticipated that a large proportion of coaching time will be spent with the team of Javier Bello & Joaquin Bello. This involves planning and leading daily training sessions focused on improving their technical/tactical skills and overall preparation for FIVB Beach Pro Tour and major international competitions in the lead up to the Los Angeles 2028 Olympic Games.
- 2. Collaborate with athletes and other staff across the beach performance programme and talent development pathway: Develop good working

relationships with all athletes and staff members, sharing best practices and contributing to a system of coaching expertise. Empower all staff members/coaches to fulfil their roles and maximise the efficiency of the programme. Support the Volleyball England Beach Performance Director in the development of a centralised system of coaching expertise.

- 3. **Assume responsibility for training and competitions**: Attend competitions with the performance athletes on a needs and prioritisation basis, with a primary focus on competitions involving the Bello brothers, while supporting other athletes as needed. Prioritise technical expertise on the sand with performance athletes in training and competition, within their own training environment as well as in the central training environment being established by Volleyball England.
- 4. **Create and maintain a high-performance environment:** Set high standards and behaviours that create a world class environment for both staff and athletes within the programme. Inspire participation and challenge athletes to strive for excellence both individually and as a team.
- 5. **Lead and support performance evaluation**: Work with the British Volleyball Federation Performance Manager to plan, monitor and evaluate athlete progress and contribute to the broader strategic plan of the programme.
- 6. **Support policymaking and selection processes**: Assist in the development of fair, transparent and effectively communicated athlete selection processes, while upholding all Volleyball England/British Volleyball Federation policies related to selection, safeguarding, data protection, equality and any other relevant policies.
- 7. **Become a member of the performance management team**: Support the British Volleyball Federation Performance Manager, while developing a clear understanding of the financial, logistical and performance review systems to benefit both the athletes and the federations involved.

BACKGROUND

The National Federations of England, Scotland, Wales and Northern Ireland (the Home Nations) are the licenced FIVB (International Federation) bodies and therefore are responsible for beach volleyball Talent pathways and performance systems in their respective countries.

The British Volleyball Federation receives funding from the UK government (via UK Sport) for the purpose of supporting performance beach volleyball athletes and teams from the Home Nations¹ and collaborates with the Home Nations' respective National Federations in setting the strategic direction for performance beach volleyball across Great Britain and transitioning athletes from the Home Nations into appropriate opportunities.

¹ These athletes train and compete under the management and direction of the British Volleyball Federation but compete for their respective home nations on the Beach Pro Tour and other international competitions, except for the World University Games/Championships or Olympic Games where they compete for Great Britain.

ADDITIONAL INFORMATION

The post-holder is expected to be fully conversant with the core requirements of the WADA Anti-Doping Code and its requirement on coaches and Team Support personnel to set a good personal example in this field. When directly working with athletes the post-holder has a responsibility to inform them appropriately of the Code's application to them and to influence them in following a 'drug-free' culture.

The post-holder's hours will be flexible to reflect the needs of the role and, while maintaining an appropriate work/life balance, will include time in evenings, at weekends and over public holidays. Standard working hours are 40 hours a week although flexibility is required in order to ensure core objectives are achieved. National and international travel will be required.

The post holder is expected to comply with Volleyball England and British Volleyball Federation policies and to undergo any relevant training as may be identified for the position. This includes but is not limited to anti-doping, safeguarding, and equality, diversity and inclusion.
