

TERMS AND CONDITIONS FOR THE QKOTC LONDON SHOWCASE 2024 PRIZE DRAW

- 1. The Promoter of this Prize Draw is Volleyball England, SportPark, Loughborough University, 3 Oakwood Drive, Loughborough, LE11 3QF.
- 2. This Prize Draw is open to UK residents aged over 18 who meet the criteria outlined in these terms and conditions. The Prize Draw is not open to employees of Volleyball England, their families, agents, or any third party directly associated with the administration of this Prize Draw.
- 3. To enter the prize draw you must have completed the online Instagram competition in full. Entries are open to residents of the UK mainland only.
- 4. The closing time and date for the Prize Draw is 11.59pm on Sunday 29th September 2024.
- 5. The winner(s) will be chosen from a random draw of entries received in accordance with these Terms and Conditions. The draw will be performed by a random computer process administered by the promoter.
- 6. The first name drawn will receive a signed QKOTC match vest, a London 2012 Olympics volleyball, a 'Come and Play for Free Weekend' at SideOut Leyton or SideOut Worthing (this applies during any SideOut to All-You-Can-Play (AYCP) days to be agreed with SideOut and is for a maximum of five people), five days of food from Fresh Fitness Food (to be redeemed by way of a promotion code) and a QKOTC London Showcase t-shirt.
- 7. The promoter accepts no responsibility for any costs associated with the prize and not specifically included in the prize.
